2	that the educational institution shall serve the needs of the locality more particularly.
3	that the Institution shall adopt the curriculum and syllabus prescribed from time to time.
4	that the school timings, vacations and mid terms holidays shall be as prescribed by the Government from time to time.
5	that the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
6	that the results of institution shall be satisfactory every year.
7	that the records/accounts shall be furnished to the district Educational officer or nominee every year at the time of instruction.
8	that the list of governing body shall be furnished to the District Educational Officer/ competent authority every year.

- 9 that the pay structure/fee structure fixed by the Governing body shall got approved by the District Educational Officer or nominee every year.
- 10 that all the conditions prescribed in the G.Os. and other orders which are not specified in this order shall be complied with. Otherwise the permission/PR will be cancelled.
- 11 that the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least 6 months before.
- 12 that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 that the society shall submit proposals for renewal of Extension of Temporary Recognition sufficiently in advance as per G.O.Ms.No.1, Edn., dated:1-1-94.
- 14 The above Extension of temp. Recognition is subject to a written undertaking being given by the school Management that the Recognition purely on temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre-requisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfill any prerequisite as stipulated, the Provisional Recognition now being is liable to be withdrawn at once.
- 15 The Management is requested to fulfill conditions stipulated in G.O. 9th read above within 3 months and submit compliance.
- 16 The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit the same to this office.
- 17 The management should follow the provisions of RTE Act.

6. That the results of the Institutions shall be satisfactory every year.
7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
13. That the society shall submit proposal for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
15. The Management is requested to submit Final No Objection Certificate from the Fire and Emergency Services Department within 3 months.
16. The Management is requested to fulfill conditions stipulated in G.O. 9th read above within 3 months and submit compliance.
17. The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for Extension of Temporary Recognition for the year 2021-2022.
