11. to purchase, take on lease or licence or in exchange hire or otherwise acquire property or any interest therein, and any rights easements, privileges, which the Society may think necessary or convenient with reference to any or the objectives of the Society.

12. to use the property and assets of the Society and all income from property and assets, movable and immovable, or from the works of the society as such when so ever derived from the objectives of the Society as set forth in the Memorandum of Association provided that no portion thereof is distributed among its members by way of profits, dividends, bonus or any other from, except remunerations for services rendered to the Society.

13. to draw make, accept, endorse, discount execute and issue cheques, promissory notes bill of lading and other negotiable or transferable instruments.

14. to open and operate accounts of any description in any bank or banks.

15. to do all such other lawful things as may be incidental to or conducive to the attainment of the above objectives.

3. DATE OF FORMATION : The Society shall be deemed to be formed on 10th day of November, '91.
4. JURISDICTION : The Office of the Society is situated in the Jurisdiction of the Registrar of Societies, Nellore, Andhra Pradesh.
5. WORKING HOURS : The working hours of the Society shall be from 9.00 am to 5.00 p.m on all working days.
6. OBJECTS : The AIMS & OBJECTS, for which the Society is established, are mentioned in the Memorandum of Association.
7. ACTIVITIES IN FURTHERANCE OF OBJECTS :
- a) to impart education to students in systematic and modern lines.
 - b) to provide residential type of education to the students.
 - c) to conduct debates and seminars on different subjects and topics relating to national or international affairs at district, state and national level.
 - d) to conduct cultural programmes and competitions at the district, state and national level.
 - e) to establish research institutions for developing new methods of education at schools and colleges.
 - f) to promote the sports bodies for developing different types of sports and athletics and to conduct sports and athletic meets at different levels.
 - g) to undertake such other activities in furtherance of the objects of the society.
8. AUTHORITY TO SUE : The Secretary of the Society shall be authorised to sue or to be sued on behalf of the Society.

10. MEMBERSHIP

- a) The subscribers to the Memorandum of Association and all such persons and their managing committee may from time to time admit to the membership shall be the members of the Society.
- b) Membership is open to all individuals irrespective of caste, creede, religion sets or community.
- c) The Executive Committee shall have powers to admit or refuse to admit any person as a Member without assigning any reason for the refusal of Membership.
- d) Membership fees shall be Rs.50/- per ann and shall be paid within 15 days of admissic as member in case of new members and shall be paid inevery January subsequently.
- e) The failure to pay membership fees for two consecutive years will result in forfeiture of membership.
- f) The Geneal Body shall have the right to remove any member of the body Society by a simple majority decision if it is convinced that he/she is acting against the objects of the Society.

11. RIGHTS, OBLIGATIONS AND PRIVILEGES OF THE MEMBERS

- a) The Members of the Society shall have the right to inspect the Register of Members and other documents related to the functioning of the Society. The Members shall have the right to question the functioning of the Society during the General body meeting.
- b) All Members shall have an obligation to abide by the Memorandum of Association and By Laws of the Society.
- c) All the Members shall have the privilege of attending the Geneal Body Meeting.
- d) Executive Committee Members alone shall have the privilege of attending the Executive Committee Meetings.
- e) The copies of By Laws, Income and Expenditure Account and the Balance Sheet shall be supplied to the Members, on application and on payment of fee Rs.5/-

12. MANAGEMENT

- a) The Management and control of the Society shall vest with the Executive Committee of the society and the Executive Committee shall, consist of Chairman, Vice Chairman, Secretary, Joint Secretary, Treasurer and six members.

13. FUNCTION OF THE OFFICE BEARERS

- a) There shall be at least one meeting of the Executive Committee in every three months.
- b) There shall be 7 days notice of each Executive Committee Meeting.
- c) The quorum for a Meeting shall be not less than half the total number of Members of the Executive Committee at any time, provided that the quorum shall at no time be less than three.

15. MEETINGS OF
THE GENERAL
BODY

- a) The Annual General Meeting of the Society shall be held at least once in a financial year i.e., before 31st day of March.
- b) A minimum of 21 days notice in advance shall be given to the Members of the Society about the Annual General Meeting.
- c) The Meetings of the General Body shall be presided over by the Chairman and in the absence of the Chairman by the Vice-Chairman.
- d) The annual General Body Meeting shall be convened for transacting the followings:-
 - 1. To receive and approve the Annual Report of the Executive Committee.
 - 2. To receive and approve the audited statement of accounts of the Society together with the Auditors report.
 - 3. To appoint auditors.
 - 4. To admit or remove the members of the Society.
- e) If one-third members of the Society want to convene an extraordinary General Meeting of the Committee then they shall submit a requisition in writing to the Chairman or vice Chairman and the Meeting shall be convened within one month from the date of the receipt of the requisition.
- f) Special resolutions shall be carried out as provided by the rules of the Societies Registration Act.

16. FUNDS OF
SOCIETY

- a) The funds of the Society shall be deposited in any of the Nationalised Banks in India in the name of the Society and the Bank account therein shall be operated jointly by the Treasurer and the Secretary of the Society.

c) The Executive Committee shall have the power to apply the funds to acquire the movable and immovable properties in the name of the Society to fulfil the objects of the society.

d) No funds shall be earmarked for the purpose of making provision for a dependent of a deceased or a disabled members.

e) The funds of the society shall be invested in the modes specified under the provisions of Section 13(1)(d) read with Section 11 (s) of the Income Tax Act, 1961.

17. ACCOUNTS AND AUDIT

a) The Accounting year of the Society shall be the financial year i.e. from 1st April to 31st March of every year.

b) The first Auditors of the Society shall be appointed by the Executive Committee upto the conclusion of the first annual General Meeting and later on the Auditors of the Society shall be appointed in the Annual General Meeting.

c) The Auditors of the Society shall be a qualified Chartered Accountant or a firm of qualified Chartered Accountants.

18. BREACH OF BY LAWS :

Disciplinary action shall be taken as per the provisions of this by-law for the breach of the provisions of by-law but no fine shall be imposed.

19. MEMBERS AS STAFF :

The Members of the Society may also be appointed to staff positions in the academic and non academic programmes of the Society and the members of the Society are not entitled to any remuneration out of the funds of the Society except travel on Society's business and sitting allowance for the days of Meetings. This provisions shall not apply to the Members of the Society serving as full time staff of the Society and its programme.

20. AMENDMENT :

The Constitution of the Society can be amended at the Annual General Meeting by 2/3 majority of members present and voting and the same shall be approved by the Commissioner of Income Tax having Jurisdiction over the Society.

21. DISSOLUTION :

The society can be wound up by three-fourth majority vote at an Annual General Body Meeting and the assets
